### RECOMMENDED PRACTICES

#### General

Grazing and Farm Development Lease Information signs are informational signs that are placed on leased public land near provincial highways to identify the property owner and the conditions that apply to entering the land.

The Public Lands Act aims to balance the need of leaseholders to protect the land and their livestock from harm with the rights of recreational users for reasonable access. The Public Lands Act requires leaseholders to allow public access to the land as long as it poses no harm to the land or to their investment in crops or livestock. Under Alberta Regulation (AR) 228/2003 of the Public Lands Act, before recreational users enter the land, they must get in touch with the person leaseholders have named as the contact person for the grazing or farm development lease. Grazing and Farm Development Lease Information signs are one way of providing the necessary contact information and identifying the permitted/prohibited activities.

Grazing and Farm Development Lease Information signs can be placed within the highway development control zone upon receipt of а permit. The highway development control zone is defined under AR 326/2009 of the Highways Development and Protection Act (HDPA) to be within 300 metres of the highway right-of-way boundary or within 800 metres of the centre point of an intersection of the highway with another public road for freeways, multi-lane provincial highways and major provincial highways. For minor provincial highways, Alberta Transportation is only responsible

for signs posted within the highway right-ofway. The Roadside Management Classification Map identifies the different highway classes and can be found on the Alberta Transportation website.

#### Application Eligibility

Any individual or organization that is leasing public land from the Alberta Government can apply for a permit to implement a Grazing and Farm Development Lease Information sign.

#### **Standard**

Grazing and Farm Development Lease Information signs should follow Drawing ID-413. The sign should contain the name of the grazing or farming lease, lease number, leaseholder contact information and prohibited activities. The overall sign size must not be greater than 3 square meters.

AR 228/2003, clause 6(1), allows the leaseholder to deny access, or introduce conditions to access, when any of the following characteristics apply:

- Access would be anything other than foot access, including bicycles, horses or other animals and motor vehicles.
- The proposed use would occur in a fenced pasture where livestock are present or on cultivated land on which a crop is growing or has not been harvested.
- Access to all or part of the agricultural disposition land has been prohibited due to a fire ban as determined by either the Provincial or municipal authority.

- The proposed use would involve hunting at a location that is unreasonably close to a fenced pasture in which livestock of the agricultural disposition holder are present.
- The proposed use is camping.
- The proposed use would be contrary to a recreational management plan, an order by the Minister prior to the establishment of a recreational management plan, terms and conditions imposed by a local settlement officer or director or an access order issued by a director.

Grazing and Farm Development Lease Information signs are intended to be read by individuals entering the leased land. The signs are not intended to be read by motorists on a provincial highway. The final sign design with completed text will be reviewed by Alberta Transportation to ensure that motorists on the highway will not be distracted by the sign.

In accordance with AR 326/2009 of the HDPA, clause 15, a permit will not be issued to any sign in the highway development control zone that has the following characteristics:

- Displays an intermittent, flashing or rotating light or lights;
- Flood lighting in such a manner as to cause interference to the motoring public;
- Yard lights, area lighting or other lights that, in the opinion of the Operations Manager, are excessively distracting to the public or create a traffic hazard;
- Has moving or rotating parts; or
- Bears a legend giving a command such as "stop, stop ahead, turn, caution," etc., or any legend that in

any way imitates a standard or commonly used traffic signal device or sign.

#### **Application Process**

Grazing and Farm Development Lease Information signs can be installed in the highway development control zone upon receipt of a permit.

To apply for a permit, an application must sent to the relevant Alberta Transportation district office(s). The application must include an image of the sign, sign locations and justification for installing the signs. The image of the sign should clearly show or identify the sign specifications, including the sign size, colour, wording and text size.
