# VENDOR CLAIMS AND INFORMATION

Beet 55 can be used proactively as an anti-icing product. Derived from a sugar beet by-product, when Beet 55 is blended with sodium chloride brine (at a ratio of 65% brine/ 35% Beet 55) the freeze point is lowered from -8C to in excess of -26C. This blend which has reduced chloride concentration is 70% less corrosive than the sodium chloride brine alone. Beet 55 enables traditional anti/de-icing products (road salt, sodium chloride) to remain effective at much lower temperatures than they would by themselves. Beet 55 is non-TDG regulated, and is considered to be an environmentally friendlier alternative.

## DESCRIPTION

Beet 55 is primarily derived from a sugar beet by-product. When blended with a sodium chloride brine (at a ratio of 65% brine/35% Beet 55), the product becomes what is known as Beet 55 Juice. Beet 55 Juice therefore has a chloride concentration of approximately 17%.

## POTENTIAL USAGE

Suitable for use in Anti-Icing, De-Icing, Pre-Wetting systems, Sand stockpile treatments (freeze-proofing), and Salt stockpile treatments (melting enhancer).
