The product addresses corrosion and environmental issues with conventional salt while offering superior snow melting performance. ECO-ST minimizes the cost of repairing roads, bridges, vehicles, and guardrails by preventing accidents and minimizing steel corrosion and concrete breakage rates. ECO-ST is 166% more effective when compared with sodium chlorides solutions for snow melting performance while providing a level of maintenance up to 3 times greater than calcium chlorides. ECO-ST boasts a major reduction in corrosion rate, close to 0%, at 0.8% corrosion, far exceeding the standard 30% corrosion rate required for an eco-friendly deicer.
