### RE: Review of Excel PP5-8 Turf Reinforced Mat (TRM)

#### PRODUCT

Excel PP5-8 TRM, a Permanent Erosion Control Blanket, is manufactured by Western Green located in Evansville, Indiana. It is distributed in Alberta by Nilex located in Edmonton.

## VENDOR CLAIMS AND INFORMATION

## CLAIMS:

Excel PP5-8 TRM has a RUSLE Cover Factor of 0.15 and is typically suitable for slopes up to 2H:1V. It is rated for channel flows up to 1.8 m/s and 72 Pa shear stress for unvegetated condition and 3.7 m/s of flow and 383 Pa shear stress for vegetated condition. It has Tensile Strengths of 4.4 kN/m (MD) and 3.2 kN/m (TD). Website: <u>https://www.westerngreen.com/</u>

#### **DESCRIPTION:**

Excel PP5-8 is a permanent, three-dimensional TRM that provides immediate erosion protection and long-term turf reinforcement and is intended for slope or channel applications requiring erosion protection for greater than thirty-six months. It is composed of 100% synthetic components. A matrix of green synthetic fibers is mechanically (stitch) bound between two UV stabilized, heavy-duty synthetic nets. Stitching is secured on two-inch centers using UV stabilized, heavy-duty Polypropylene thread. It is 9mm (0.34") thick.

#### POTENTIAL USAGE:

Typical applications are for highway ditches, and embankments for slopes up to 2H: 1V.
