## **RECOMMENDATIONS**

### **RESTRICTIONS ON USE**

#### Caveat:

- 1. Required height is 35 to 38 inches;
- 2. Acceptable product shape is "short squeeze" or round (with cap or open top);
- 3. Square Surface-Mount Base (fixed base or quick release base) is acceptable.
- 4. The base of the product is to be fixed to the roadway using bolts and plugs (not with adhesive materials) according to manufacturer's specifications.
- 5. The separation between the bases to be at least 150 mm.

6. The reflective sheeting material and placement shall be in accordance with the requirements of Specification 5.28, Supply of Flexible Guide Post Traffic Delineators.

- 7. White reflective sheeting to be used with white posts. Yellow reflective sheeting to be used with yellow posts.
- 8. Top 300mm of the post should be black in colour (powder coating) to provide contrast to the surrounding environment.
