### **CLAIMS:**

Propex's first generation TRMs are constructed of a dense web of 100% polypropylene fibres positioned between 2 biaxially oriented nets. When vegetated, they provide twice the erosion protection of vegetation alone. Now we've taken the same woven technology in our High Performance TRMs and used it to design the next generation of TRMs. All Landlok TRMs feature patented X3 fiber technology, which provides 40% greater surface area for trapping and protecting seed and soil.

### **DESCRIPTION:**

These netless, composite-free 3-dimensional second generation TRMs feature a rugged material construction that combines superior tensile strength, flexibility and UV stability. This allows them to deliver better, long-term performance over traditional methods like rock riprap and concrete paving and increased design life over first generation netted, fused, glued or stitch-bonded TRMs.
