


### **How to Complete the Driver Training Records Report**

The *Driver Training Records Report (DPLS0034)* form is used to capture information about **each student** who takes driver training in a given calendar year. It is located at: <a href="http://www.transportation.alberta.ca/4936.htm">http://www.transportation.alberta.ca/4936.htm</a>. **Driver training organizations must report every student who takes driver training with them, regardless of whether it is part of a standardized course or if it is hourly lessons.** 



Name of Driver Training Company: Type into the gray field the legal name of your driver training organization. Please ensure you are using the name that appears on your licence/certificate.

Driver's Licence Number: Type in field the student's driver's licence number (i.e. 1234567-123). Dashes (-) should be used where applicable. If the student does not have a driver's licence, type "No driver's licence" in the field. If you did not collect the information, type "Not Collected" in the field.

Jurisdiction that Issued Student's Driver's Licence: Select from the dropdown menu, the province that issued the student's driver's licence. The options available for selection and an explanation of what they mean are in the table below:

Option	Explanation
Alberta	Use to indicate the student's driver's licence is an Alberta driver's licence.
All other Canadian provinces and territories (i.e. British Columbia)	Use to indicate the student's driver's licence from elsewhere in Canada.

Alberta Driver's Licence Class: Type in field the class of Alberta driver's licence that the student had at the time they took the training. - Completion Form Number (if applicable): Type the number on the completion form issued to the student. Types of training that may result in a completion form are: Air Brake Program, Class 5 In-Vehicle 10 hours, Class 5 In-Vehicle 6 hours, Defensive Driving Course Classroom, Defensive Driving Course Online, Professional Driver Improvement Course Classroom, Professional Driver Improvement Course Ught Duty Vehicles, Professional Driver Improvement Course Online, and School Bus Driver Improvement Program. Submission: The form captures data for all students trained in the previous calendar year (i.e. January 1, to December 31, 2019) and must be submitted yearly to Alberta Transportation by March 31 of the current calendar year (i.e. March 31, 2020). The data reported must use the terminology in this document and must be submitted electronically in a Microsoft Office Excel compatible format.
