### I) Accessible Transportation Complaints

The Canadian Transportation Agency launched two new resource tools for travellers with disabilities and for transportation service providers to improve their access to and understanding of the Agency's process for resolving disputes within the federal transportation network.

These new client-centred resource tools explain the Agency's approaches in resolving accessible transportation complaints between persons with disabilities and service providers of the federal transportation network. More specifically, the tools:

- provide information on how to file a complaint regarding an "undue obstacle" experienced by a person with a disability;
- guide applicants and service providers through the process to resolve a dispute, from initial contact with the transportation service provider to informal and formal dispute resolution options with the Agency; and
- clarify the key questions addressed during formal adjudication and explain the approaches the Agency uses in resolving accessible transportation complaints.

The <u>Accessible Transportation Complaints: A resource tool for persons with disabilities</u> and the <u>Accessible Transportation Complaints: A resource tool for transportation service providers</u> can be accessed in multiple formats, including e-Reader, through the Canadian Transportation Agency's website. ### A) Federal Government

#### **ALBERTA TRANSPORTATION**

#### Alberta Municipal Infrastructure Program (AMIP)

The AMIP supports the development, enhancement and rehabilitation of core capital infrastructure projects, such as municipal roads, bridges, public transit vehicles and facilities, water and wastewater systems and facilities, storm drainage systems and facilities, emergency service vehicles and facilities and infrastructure management system software. The program may include barrier free transportation initiatives, such as the purchase of low-floor buses and handi-buses, to improve accessibility for seniors and persons with disabilities.

AMIP will also fund barrier free upgrades and retrofits to access municipally owned infrastructure. Eligible projects include installing accessible pedestrian signals, curb cuts, and wheelchair ramps. Further information can be found at:
