BETWEEN:

HER MAJESTY THE QUEEN IN RIGHT OF ALBERTA ("Alberta"),

as represented by the Minister of Transportation ("Minister")

OF THE FIRST PART

- and the -

OF THE SECOND PART

AMENDING AGREEMENT

WHEREAS the Minister and the Municipality entered into a memorandum of understanding dated the **30th** day of **June 2005** (the "2005 Agreement");

AND WHEREAS the Parties are desirous of extending the 2005 Agreement for a further four year term;

AND WHEREAS the Parties agree to amend the 2005 Agreement as contained herein.

IN CONSIDERATION of the mutual covenants contained in this Amending Agreement, the Parties agree as follows:

1. Section 14 is struck out and the following inserted:

"This Memorandum of Agreement shall continue in effect until March 31, 2014 and may be renewed thereafter if mutually agreed in writing. To facilitate efficient planning, any renewal period should be implemented before the expiry date."

- 2. Section 15 is amended by striking out "March 31, 2010" and inserting "March 31, 2014".
- 3. Schedule 1 is deleted in its entirety and Schedule 1 attached hereto is inserted.
- 4. All other terms and conditions of the 2005 Agreement, except where amended by this Amending Agreement, continue to be in full force and effect.
- 5. All capitalized terms shall have the same meaning as in the 2005 Agreement unless otherwise defined herein.
