PRODUCT

AEC Premier Straw Single Net / FibreNet Erosion Control Blanket is manufactured and distributed in Alberta by American Excelsior Company located in Rice Lake Wisconsin.

VENDOR CLAIMS AND INFORMATION

CLAIMS:

AEC Premier Straw Single Net is a natural, stitched straw blanket that provides a temporary organic cover to reduce erosion, protect seeds, enhance germination, and hasten re-vegetation. Its rolls are stretch wrapped to protect against the elements prior to installation. It has a design soil loss ratio of 0.05, channel flows up to 1.4 m/s and 74 Pa shear stress. DESCRIPTION:

AEC Premier Straw Single Net consists of the finest available agricultural straw with 75% four-inch or greater fiber length. The fibers are evenly distributed throughout the entire area of the blanket. The top of each blanket is covered with degradable polypropylene netting. It is also available with 100% biodegradable jute netting and is called AEC Premier Straw Single Net FibreNet.

POTENTIAL USAGE:

Typical applications are for highway slopes and embankments for slopes up to 3H:1V.
