Crafco Mastic One is a flexible material; durable (supports heavy loads); waterproof, bonds to AC and PCC pavements. The Crafco Mastic One material is hot applied, pourable, self-adhesive patching material used for the preservation, maintenance and repair of asphalt and Portland cement concrete pavements. #### **DESCRIPTION**

Crafco Mastic One is a hot applied, single component, pourable, aggregate filled, polymer modified asphalt mastic used for maintenance, repair and preservation of pavement and bridge surfaces.

## **POTENTIAL USAGE**

Grafco Mastic One is used for sealing, filling and repairing many distresses in both asphalt concrete and Portland cement concrete pavements that are larger than those typically repaired by crack or joint sealing, but smaller than repairs requiring remove and replace patching procedures. Examples of this products use are: Sealing and Filling pavement cracks or joints over 3.8 cm wide; filling potholes; leveling depressed thermal cracks; sealing and repairing longitudinal joints; skin patching; leveling manhole covers, bridge deck approaches; filling spalls, and pop outs.
